The Dean is ultimately responsible for 125+ full time faculty, 45+ staff and a total budget of approximately \$27 million (most benefits and physical plant costs are budgeted centrally).

The Dean was also a member of the Academic Deans' Council and Leadership Advisory Council. The College of Business contained the Departments of Accounting, Finance, Management, Management Information Systems, Marketing, Risk Management/Insurance, Real Estate and Business Law and the Dedman School of Hospitality. After a 2009 reorganization Management and Information Systems was merged with Management and the Dedman School of Hospitality became an independent school reporting to the Dean. In 2013 the Dedman School started the process of reinstituting its business degree. In 2013, the Management Department was split, creating an Entrepreneurship, Strategy and Information Systems Department. The

College was home to several centers and institutes, including The Jim Moran Center for Global Entrepreneurship, The Center for Human Resource Management, The Real Estate Education and Research Center, Gene Taylor/Bank of America Center for Banking and Financial Studies, Florida Catastrophic Storm Risk Management Center, Sales Institute and the Marketing Institute.

The College had approximately 5700 undergraduate majors, 300 master's students and 70 Ph.D. students. The College had undergraduate programs in accounting, entrepreneurship, finance, human resource management, marketing, professional sales, management information systems, management, professional golf management, retail management, real estate, risk management and insurance, and hospitality administration. It had the following masters degrees: Master of Business Administration (on the Tallahassee campus and online), Master of Science in Finance, Master of Science in Marketing, Master of Science in Management Information Systems (online), Master of Risk Management and Insurance (online) and a Master of Accounting. The College offered a Ph.D. in Accounting, Finance, Marketing, Management Information Systems, Organizational Behavior, Strategic Planning, and Risk Management and Insurance. Seven department heads, two associate deans, budget director, college alumni director, college public relations director, and technology director reported directly to the Dean. The Dean also managed five full time development officers, communications, public relations and administrative staff that supported the college. The Dean was ultimately responsible for 115 full time faculty, 50+ staff and a total budget of approximately \$30 million (benefits and physical plant costs were budgeted centrally).

## Chair-Florida State University Student Investment Fund (2009-2015)

The Student Investment Fund is a separate 501(c)(3) established to receive and manage monies dedicated to the Student Run Investment Fund located in the College of Business. Board met four times a year and consisted of designees from the university as well as several financial experts, appointed by the President. Oversaw the student management of \$2 million provided by the Florida State Foundation as well as over \$400,000 provided by private donors.

This included advocacy, budgeting, development and alumni relations. The Dean was also a member of the Provost's staff and participated in the university's executive committee. The College of Business contained the Departments of Business Administration (finance, marketing, and production), Business Information Systems (information systems, business and marketing education), Economics (jointly administered with College of Agriculture), Management and Human Resources and a

School of Accountancy. The College also administered the Apparel and Textiles degree. The College was home to the Partners in Business Program, a 36 year old management education seminar series, that was student staffed with over 900 students participating each year, the Shingo Prize for Excellence in Manufacturing, an award and recognition program for manufacturers in North America, and the Center for Transfer and Commercialization of Cleaner Technologies.

The College had approximately 2400 undergraduate majors and 350 graduate students. The College granted undergraduate degrees in finance, marketing, operations, information systems, business and marketing education, accounting, management/entrepreneurship, economics and human resources. It had the following masters degrees: Master of Business Administration (on the Logan campus and at three different locations throughout the state), Master of Science in Business Information Systems (both on the Logan campus and provided on the university satellite system), Master of Science in Economics, Master of Science in Human Resource Management (both on the Logan campus and provided on the university satellite system) and a Master of Accounting. The College also jointly administered a Ph.D. in Business Information Systems and Economics and participated in the university's distance doctoral program. Five department heads, one senior associate dean, two associate deans and one director reported directly to the Dean. The Dean managed two full time development officers, advisors and staff in the College advising and internship center, and the technology, communications, public relations and administrative staff that support the college. During this time period the Dean was ultimately responsible for 70 full time faculty, 40+ staff and a total budget of approximately \$10 million (benefits and physical plant costs are budgeted centrally). The College had robust programs both on the Logan campus and throughout the state of Utah and in China through Continuing Education.

#### Chair- Utah State University Research Foundation Audit Council (2002-2006)

The Research Foundation is an A-122 subsidiary of Utah State University. The Audit Council had oversight responsibility for all financial aspects of the Foundation and reported directly to a sixteen member Board of Trustees. Between 2002 and 2006, the Foundation's extramural research funding ranged from \$45 million to \$87 million. The Foundation had three units, the Space Dynamics Laboratory, BioMolecular Systems Laboratory and Water Dynamics Laboratory. In addition, the Technology Commercialization Office and the Innovation Campus were also part of the Foundation. The Chair of the Audit Council was responsible for ensuring that the Board had sufficient financial detail to determine the financial integrity of the Foundation and suggested strategic direction to the Council.

#### **Chair-** *Utah State University Health Benefits Committee* (2002-2005)

The Utah State University Health Benefits Committee was appointed by the President and comprised of faculty, staff and community members. It was responsible

for monitoring the financial health of the university's self-funded health insurance plan and for making recommendations to the President for changes. During this time period the committee successfully facilitated a change in the plan from a single plan to a dual plan. It also successfully facilitated significant changes in the prescription drug coverage.

## **Highlighted Leadership Accomplishments**

#### **Association Activities**

AACSB, Intl

- Created New Executive Team: The existing leadership team was composed of 12 individuals of varying rank and influence. The composition of the existing Leadership Team was reevaluated to ensure that the organization had the executive leadership needed to respond to the crisis and to move the organization forward. After a thorough review, it was determined that all members of the existing Leadership Team were productive and valued, although some positions were no longer needed. Six individuals were selected which now compose a new Executive Team. This team has been responsible for successfully navigating the disruption occurring due to the pandemic. The Executive Team is responsible for establishing and implementing strategic goals.
- New Leadership Model: A new AACSB Leadership Model aimed at aligning the
  performance system with strategic goals. A new performance system was
  implemented and is used to track staff performance, including quarterly check-ins,
  and will be used to assess staff annual performance. The verticals have been
  reorganized to better align with the strategy and allowing a seamless transition
  when an EVP retires in Dec. 2022.

- Developed Agile Strategic Plan: Adopted by the Board Feb. 2021. The plan identifies five specific goals, objectives to achieve those goals and KPIs that can be tracked. All of the individual units are aligned with the strategic goals and each unit has prepared detailed tactics to achieve performance measures that support the goals. Limited hiring based on a new strategic structure has begun. These hires are aimed at ensuring the organization moves boldly into the future.
- Maintained Financial Strength and Stability: The 2020-2021 budget finished with a surplus. This was accomplished by a combination of one round of employee layoffs for budget reasons. This round of layoffs was instituted four weeks from my start date. A second round of layoffs was implemented for strategic reasons. Besides these reductions in personnel costs, other human resource actions impacting existing employees was implemented. All events and seminars were moved online and the membership team aggressively worked to retain existing members as well as adding additional educational and business members to the Business Education Alliance. All of these actions, as well as the receipt of COVID relief monies from the different governments, resulted in the surplus. A surplus is anticipated for 2021-2022.
- Staff Communication (currently all virtual): Meet 1-1 with each staff member twice a year. Monthly all staff forums have been implemented that includes organization updates and a polling system where staff can ask any questions anonymously.
   Periodic "coffee chats" have also be instituted, where a member of the Executive Team, myself and between 6-8 other staff members from different areas, meet informally to check in.
- Prioritize, Develop, and Pilot New Products to Attract and Retain Members: The
  Chief Learning and Development Officer role has changed to become the Global
  Chief Product Officer and has been tasked with developing new products. A
  pipeline of potential products has been identified and prioritized. A consulting firm
  has been hired, has completed an assessment and is now working with our data
  and technology teams to expedite the creation of new products.
- Implemented 2020 Standards, Volunteer Training and Connected for Better Campaign: Standards were passed by over 80% of the accredited members, the online/remote volunteer training was developed and 200+ individuals have completed it. Initially 21 pilot schools participated in virtual visits under the new standards. The Connected for Better Campaign has been very successful.
- Hired New Human Resource Director charged with evaluating all of the Human Resource Practices and providing recommendations, creating a Human Resource strategy including Diversity and Inclusion goals, creating new merit pay structure and updating all Human Resource policies.

 Role of Chief Diversity and Inclusion Officer: Took over the role of Chief Diversity and Inclusion Officer, tasked the internal Diversity and Inclusion Committee to create goals, an implementation schedule and to sponsor quarterly D&I internal events for staff. An employee cultural engagement survey has been completed.

### **University Activities**

Santa Clara University (2015-2020)

- Initiated and completed a new Strategic Shift process involving faculty and staff. The process resulted in five new desired states for the Leavey School of Business. Each desired state has a one year, three year and five year implementation plan. Each department, center/institute and unit also completed strategic shift documents aligned with the School's. Budget allocations were also aligned with the strategic initiatives and many budget decisions were decentralized. A sample of the School initiatives include:
  - ✓ Ciocca Center for Innovation and Entrepreneurship (formerly the Center for Innovation and Entrepreneurship). Re-visioned the Center to be a university wide hub for Ignatian informed entrepreneurial thinking across campus. Includes new course development for both the design thinking pathways a well as the popular entrepreneurship minor, new student programming, faculty research grants, four new tenure track hires, four new entrepreneurs in residence hires and a university accelerator. New executive director has been hired. Program administrator and administrative assistant are in the process of being hired. Partnership with the School of Engineering, School of Education and Counseling Psychology, School of Law and the College of Arts and Sciences. Received \$11 million donation in May 2019. Center was named for the lead donors.
  - ✓ New Real Estate program initiative was proposed and accepted. Focus groups of prominent real estate alumni and friends were held. A Real Estate Leadership Advisory Board was formed as was a student interest group. Two new real estate courses were developed and taught by members of the advisory board. A real estate minor was established Winter 2018. First real estate mini-conference was held May 4, 2017 with over 200 in attendance. The second conference May 9, 2018 with over 450 in attendance. Third conference was held May 2019 with over 500 attendees. Fundraising for a \$6 million Institute is ongoing. Almost \$2 million has been pledged. Joint initiative with the Law School.
  - ✓ Conscientious Capitalism initiative was proposed and accepted. It is a partnership between the Leavey School of Business and the Center for Conscientious Leadership. First undergraduate class was developed and

- taught Winter 2017. A Speaker Series has been launched focusing on exemplars of conscientious leadership. Inaugural speakers include Howard Behar, past President board member Starbucks, John Donahoe, former CEO Ebay, Admiral Eric Olsen, former Commander of Navy Seals and David Krane, Managing Partner at Google Ventures. The initiative partners with the Markulla Center for Ethics, Miller Center for Social Entrepreneurship and the Ignatian Center.
- ✓ Initiative for Women's Economic Empowerment (IWEE). Three focus groups were held and the women attending are employed at the highest levels in Silicon Valley companies. Questions revolve on how to "move the needle" on diversity and inclusion at all levels in organizations primarily in tech related fields. Two working groups have emerged. One is focusing on mentoring. The other is focusing on a convening event. Partnership is with the Miller Center for Social Entrepreneurship and is being extended to include the College of Arts and Sciences and the School of Engineering.
- Successfully led the College through various accreditation and accountability review processes.
  - ✓ AACSB accreditation for both business and accounting was renewed in 2016.
  - ✓ The departments of Finance and Marketing completed university required quality reviews.
  - ✓ Tasked an associate dean and faculty governance groups to provide recommendations for an overhaul of the College assessment program. This resulted in a significantly streamlined approach with greater impact.
- Completed negotiations with a third party for a new online MBA Program launched January 2018. Worked with faculty groups and central staff to obtain buy in and support.
- Restructured Graduate Program Office and Graduate Degrees.
  - ✓ MBA degree has been totally redesigned with focus on Silicon Valley. Launched Winter 2017.
  - ✓ Online MBA designed and successfully launched Winter 2018.

#### Selected initiatives include:

✓ Created the vision and led the fundraising effort for a new \$75 million building, "Legacy Hall," which will be located in the new Arena District. Worked collaboratively with the President, Vice President for Finance and Administration, Provost, City, County, business leaders and others to reposition the area as a new gateway to campus and to the Capitol.

- Involved master planning for venues such as a hotel/conference center, retail, professional office space and basketball arena.
- ✓ Partnered with First Commerce Credit Union to start a new community oriented "Power Forward" series aimed at business professionals. Headliner for the 2013 event was Barbara Corcoran of Shark Tank fame. Event sold out with over 600 attendees. Headliner for the 2014 event was Steve Wozniak, co-founder of Apple. Venue changed and the program accommodated around 900 attendees.
- ✓ Led the vision, planning, and public presentations for two of the university's "Big Ideas." The Entrepreneurial University and the Risk Initiative were initiated by the College and include the participation of many colleges across the campus. Because of these efforts, the State of Florida's CFO's Office partnered with the College of Business' The Jim Moran Institute for Global Entrepreneurship to cosponsor a statewide economic development conferences aimed at creating, attracting and retaining jobs in Florida. In the 2013 legislative session, the state provided an additional \$15 million to support the Entrepreneurial University Big Idea which is aimed at helping FSU move into the top 25 public universities and entrepreneurs in residence are being added to every college. Partially as a result of these early efforts, in December 2015 Florida State University announced a \$100 million gift from the Jan and Jim Moran Foundation to create The Jim Moran School of Entrepreneurship.
- ✓ Received an increase of \$400,000 to hire entrepreneurs in residence in the College of Business and to open up our entrepreneurship minor to all university students. The entrepreneurship minor began fall 2013. Further, a sophomore level introduction to innovation and entrepreneurship course was developed to expose students to entrepreneurship earlier in their academic careers.
- ✓ Received a \$4.25 million lead gift for the Entrepreneurial University Big Idea, received April 2011 for the Jim Moran Institute for Global Entrepreneurship, allowed the expansion of several activities, including the InNOLEvation Business Plan competition, E- Month, Student Business Incubators and others.
- ✓ Worked with the Dean of Faculties and small group of administrators to revamp the biannual Deans and Chairs conference to be more interactive and to focus on higher education issues. First newly formatted program used the book "The Great American University" to engage university administrators in discussions surrounding how great universities are formed and how they thrive.
- ✓ Initiated and obtained private funding for facilitated process resulting in new vision and mission statements. Engaged faculty, staff, students, alumni and business professionals in strategic planning process and

- completed a new strategic plan for the College with measurable outcomes. Faculty driven College Strategic Planning Committee reviews plan and implementation activities annually and makes recommendations for changes.
- ✓ All departments and units completed individual strategic plans aligned with the College plan. These plans are now being used to make decisions about funding, faculty hiring and program support.
- ✓ Initiated the Sunshine State Ethics in Leadership Award, the only award of its kind in Florida. The award recipients are selected by the College of Business Ethics Roundtable and honor two individuals (one in the private sector and one best known for service in the public sector) who have demonstrated a deep and unwavering commitment to the highest levels of integrity, ethical behavior and principled leadership.
- ✓ In 2007-2008 led the College through a 4% permanent budget cut and an additional 3.5% budget cut (we received 2 years of nonrecurring funds to try to partially offset this cut). In 2008-2009, led the College through an additional 6% permanent budget cut.
- ✓ Worked with three other deans to encourage the university to allow the academic units to charge market rates for online programs. This required a legislative statutory change, a change in the rules by the state Board of Governors, and several rule changes by the university auditors.
- ✓ Supported the establishment (with space and seed funding) of a College Veterans Center aimed at improving the assimilation of veterans returning to school. This work helped set the groundwork for a university-wide veteran's initiative with the intent of ensuring that FSU is the most veteran friendly campus in the country. In 2013 *Military Times* ranked the College of Business No. 1 among public business schools and No. 3 among all of the 100 business schools as "Best for Vets: Business Schools" rankings.
- ✓ Directed the repositioning of the Marketing Institute. New name is the Institute for Applied Business Research and the new strategic vision has transformed the Center from a one primarily focused on transportation to a center for the study of mobility and sustainability. \$773,000+ in active contracts and grants for 2013-2014.
- ✓ Instituted a faculty technology committee creating a process whereby faculty had strategic oversight of technology issues.
- ✓ Increased the College's strategic commitment to internationalizing the College by appointing a College director for international programs; supporting the implementation of MBA courses with an international business trip experience; and supporting the negotiation and development of several international partnership agreements with like-minded universities.

- ✓ Based on faculty feedback, instituted a competitive summer faculty research program whereby faculty could qualify for summer funding for deserving research projects.
- ✓ Obtained Provost support and funding for three additional faculty members to start a new business analytics focus.
- ✓ Obtained Provost support to temporarily supplement the hiring of an eminent scholar chair in real estate. Recruited and hired the leading real estate scholar in the country to Florida State.
- ✓ Professionalized the budget and human resource functions by bringing the University Business Administrators program to the college.
- ✓ Professionalized the technology staff operation by bringing the University Technology Associates program to the College.
- ✓ Provided leadership and direction for remodels and/or relocation of dean's suite, undergraduate advising office, Ph.D. "bull pen," Insurance Center, Marketing Institute, Internship Office, Real Estate Center, Sales Lab, Florida Catastrophic Storm Risk Center, Entrepreneurship Bootcamp for Veterans with Disabilities and Jim Moran Institute for Global Entrepreneurship (JMI). The JMI remodel included space for a student business incubator where student run businesses can be launched.
- ✓ Upgraded, changed and evaluated several staff positions in order to ensure the college has the right people in the right positions. This included major restructuring of the student professional development and communications areas.
- Improved transparency and collegiality in the College in the following identifiable manner:
  - ✓ Encouraged and funded the first College faculty and staff recognition awards. Six Core Values awards are given annually and a "We Choose Excellence" award is given monthly.
  - ✓ Instituted an annual retired faculty and staff luncheon.
  - ✓ Increased internal communication by publishing minutes of executive committee meetings.
  - ✓ Periodically creating and sending electronic internal newsletter.
  - ✓ Meeting individually with each faculty member each year.
  - ✓ Holding staff retreats and/or staff luncheons for individual units.
- Enhanced the quality of College graduate programs by providing strategic direction for the following:
  - ✓ Reviewing and revising the MBA curriculum with ultimate goal of updating offerings. This effort resulted in repositioning the online and full time MBA programs and increased enrollment.

- ✓ Reviewing the Ph.D. curriculum and funding incentives with aim to reduce redundancy across departments as well as to stream line the Ph.D. curriculum to ensure that students can complete the program in 4-5 years.
- ✓ Mandated a significant reduction in Ph.D. students' teaching assignments in order to improve the quality of the undergraduate student experience and improve the ability of the Ph.D. students to focus on research.
- ✓ Encouraged the establishment of a new Master's in Finance degree. First cohort group began summer 2009.
- ✓ Encouraged the development of a new Master of Science in Marketing degree with an emphasis on Corporate Brand Management. First cohort began summer 2011.
- ✓ Encouraged the development of five online business graduate courses that are now available to departments in the College of Arts and Sciences, as well as others.
- ✓ Graduate degree in Hospitality Management was under development.
- Created new programs and opportunities for students. Some examples include:
  - ✓ New majors in Sales and Retail Management created. Revamped major in entrepreneurship. New program in business analytics was in process.
  - ✓ February 2008 created the first annual Entrepreneurship Day in conjunction with The Jim Moran Institute for Global Entrepreneurship. Several entrepreneurs attended the day and worked with the entrepreneurship students providing guidance and advice. This evolved into an E-Week celebration and starting November 2012 into E-Month celebrating entrepreneurship across campus.
  - ✓ Worked with the university central administration to create a College of Business Direct Support Organization (DSO) which houses the newly formed Student Run Investment fund (now managing over \$2 million) as well as other college programs. The goal was to create a financial model that gives the college ability to self-support many of its programs. University Board of Trustees approved the organization in September 2008 and it became a legal entity May 2009.
  - ✓ Piloted and created a new assessment process that evaluates student knowledge and student behaviors.
  - ✓ Tasked the undergraduate curriculum committee with revising the undergraduate core and tying the business core to newly developed program goals. Proposal was finished fall 2008 and college faculty approved it spring 2009.
  - ✓ Created an enrollment management committee that worked closely with the undergraduate curriculum committee. Goal was to develop new mechanisms to control undergraduate enrollment, including matching faculty resources with student demand.

- ✓ Engaged the college in benchmarking superior internship programs which resulted in an extensive report with several recommendations. Based on these recommendations the college set up the first comprehensive collegewide internship program. Director was hired fall 2008.
- ✓ Created a new student welcome event in 2008. Over 300 students attend the event, all College student clubs set up information booths, the students learn about the College integrity code, and a successful business graduate speaks about the value of the College of Business education and experience.
- ✓ Increased the activities of the Student Leadership Council, SLC. The SLC is a small group of select students who are given the opportunity to implement new programs for the College. Since 2007, this group has implemented the Golden Opportunities Mentoring program, Women in Business conference, Knowledge Exchange, Lunch with a Rotarian, Faculty/Student Meet and Greet, and a host of others.
- ✓ Encouraged the addition of student clubs that reach students across the university. Examples include Students in Free Enterprise, SIFE, Women in Business, WIB and Young Entrepreneurs Society, YES.
- ✓ Supported the creation of an internal student case competition. Winning teams go on to national and international case competitions. It was in its second year and had over 40 students participating.
- ✓ Supported the creation of a student consulting club.
- ✓ Implemented Coffee with Caryn for graduating seniors.
- Successfully led the College through various accreditation and accountability review processes.
  - ✓ AACSB accreditation was renewed in 2008 and again in 2014.
  - ✓ Working with university officials to ensure timely responses for the recently completed SACS review.
  - ✓ Each College department completed university and state mandated Quality Enhancement Reviews. These reviews included writing and negotiating separate action plans for each department.
  - ✓ Appointed faculty and staff to provide recommendations for an overhaul of the College assessment program. Started using externally generated surveys and benchmarking criteria in the summer of 2008.
  - ✓ Created a new position and appointed a college assessment coordinator to ensure that the SACs university review and continuing AACSB reviews will be handled smoothly
